

RELEASE FROM LIABILITY  
HOLD-HARMLESS AGREEMENT and CONSENT TO USE OF LIKENESSES

1. I, THE UNDERSIGNED, UNDERSTAND THAT Dickey Rural Telephone Cooperative and its Subsidiaries, including without limitation Dickey Rural Services, Inc. (sometimes also known as DRN and ReadITeCH) collectively referred to hereinafter as "DRN" is an organization led by officers and directors.
2. I understand that DRN and its officers and directors may elect not to carry any type of insurance, including liability insurance covering activities such as DRN's "TECH CAMP" and even if DRN did carry such insurance, liability insurance coverage may not cover injuries or damages suffered by me as a result of negligence or intentional acts of DRN, its officers, its directors, agents, licensees, invitees, or as a result of negligence or intentional acts of anyone else present at DRN's "TECH CAMP."
3. Further, I understand that any activity I engage in as a result of my participation in activities of DRN are voluntary and that I am not required to engage in any such activity(ies).
4. Further, I understand that it is possible that accidents or other injuries may occur to me while engaging in activities of DRN. I also understand there is a risk of contracting an infectious disease, not limited to Influenza, MRSA or COVID-19.
5. Further, I understand that DRN may make video, audio and photographic recordings of my activities during DRN's "TECH CAMP" and use such recordings for DRN's benefit in advertising and promotional materials and promotional campaigns.
6. THEREFORE, I, FOR MYSELF AND ON BEHALF OF MY HEIRS AND PERSONAL REPRESENTATIVES, voluntarily, willingly, and knowingly agree to release DRN, its officers, directors, agents, licensees and invitees from liability from any claims, demands, injuries, expenses and/or damages arising from any activities related to DRN and related to DRN's "TECH CAMP" and which result, either directly or indirectly, from the negligence or intentional acts of DRN, its officers, directors, agents, licensees and invitees; furthermore:

I hereby grant to the DRN the absolute and irrevocable right and unrestricted permission to use my name, likeness, image, voice, and/or appearance as such may be embodied in any photos, video recordings, audiotapes, digital images, and the like, taken or made on behalf of the DRN. I agree that DRN has complete ownership of such material and can use said material for any purpose consistent with DRN's wishes. These uses include, but are not limited to, videos, publications, advertisements, news releases, Web sites, and any promotional or educational materials in any medium. I acknowledge that I will not receive any compensation for the use of such images, video, likeness, etc.
8. I hereby release and discharge DRN, and its agents, representatives and assignees from any and all claims and demands arising out of or in connection with the use of my name, likeness, image, voice and/or appearance, including any and all claims for invasion of privacy, right of publicity, misappropriation or misuse of image, and/or defamation.

I represent that I, or my legal guardian also signing below, am over the age of eighteen (18) years and that I, or my legal guardian also signing below, have read the foregoing and fully understand its contents. This release shall be binding upon me, my heirs, legal representatives, and assigns.
